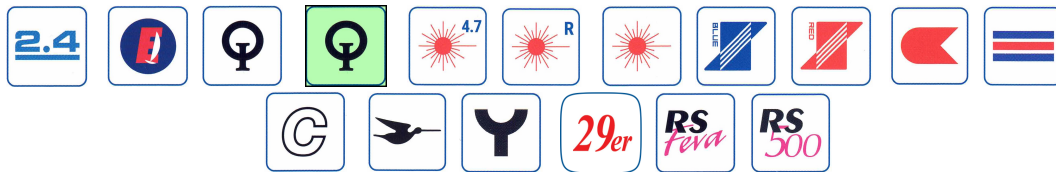


Notice of Race

1 RULES

1. The event will be governed by the rules as defined in “The Racing Rules of Sailing, RRS”, The prescriptions of the RNWA will apply. <https://www.watersportverbond.nl/wedstrijdsport/zeilen>
2. The sailing instruction may change some rules.
3. If there is a conflict between languages the English text will take precedence.
4. Every person on board who has his or her domicile in the Netherlands shall have the appropriate license.
5. RRS Appendix T, Arbitrage will apply.
6. RRS Rule 40.1 will apply at all time while afloat. RRS Rule 40.2 will not apply, so flag “Y” will not be shown.
7. Special measures will be taken in connection with the **Covid 19** regulations. They will be posted at the venue and the Covid protocol will be published on Manage2Sail.
8. Refund due to Covid 19:
 1. The registration fee will be fully refunded in the following situation resulting from the Covid 19 pandemic:
 1. Cancellation by the gouvernement.
 2. If competitors can't attend the venue due to safety measures taken by the gouvernement.
 2. Claims for travel or accommodation will not be accepted due to NOR 1.8.1.1 and 1.8.1.2 or other.

2. SAILING INSTRUCTIONS

1. The sailing instructions will be available after 01-07-2021 on Manage2Sail. (M2S)

3. COMMUNICATION

1. The online official board is located at <https://www.zeelandregatta.eu/notice-board>
2. [DP] [While racing][From the first warning signal until the end of the last race of the day], except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4. ELIGIBILITY AND ENTRY

1. The regatta is open to all boats of the classes as mentioned above.
2. All competitors shall be members of their National Class Association
3. A class will be eligible if a minimum 8 participants is entered by 01-07-2021.
4. Eligible boats shall enter by online registration: <https://www.zeelandregatta.eu/register>
5. Competitors under 18 years of age shall return a completed parent/guardian consent form prior to or at registration. This consent form will be provided automatically through online registration.
6. The online registration is open from 01-04-2021.

11. CLOTHING AND SAFETY EQUIPMENT:

1. The O.A. recommend all competitors to wear wet or dry suite while afloat.

12. VENUE:

1. The location of the regatta office and the launching area as shows in addendum A.
 1. Race office: De Roergangershut - Polredijk 13, 4351RT Veere, The Netherlands.
 2. Beach Oostwatering: 51°33'27.6"N 3°39'06.2"E.
2. Addendum B shows the racing areas.

13. COURSES:

1. The courses to be sailed can be:
 1. Windward-leeward (with an offset mark)
 2. Trapezoid course.

14. PENALTY SYSTEM:

1. Appendix P will apply.
2. Appendix P2.2 will apply for the second and all consecutive penalties.
3. Appendix P2.3 will not apply.

15.SCORING:

1. At least 3 completed races are required to constitute this regatta.
2. A boat's score shall be calculated in accordance with RRS A2, except that:
 1. When fewer than 4 races have been completed, a boat's series score will be the total of her race scores.
 2. When 4 to 8 races have been completed, a boat's series score will be the total of her race scores, excluding her worst score.
 3. When 9 to 10 races have been completed, a boat's series score will be the total of her race scores, excluding her 2 worst scores.

16.SUPPORT PERSON VESSELS:

1. Support boats shall register by using this www.zeelandregatta.eu/support-boats. An identification flag, which shall be displayed during the regatta, will be issued by the O.A. at the venue. A fee of 25€ will be asked as deposit for that flag.
2. Except requested by the race committee, support boats shall stay at least 50 meter from the area where boats might race.
3. Support boats shall not communicate with competitors during the races.

17.CHARTERED OR LOANED BOATS:

18.BERTHING AND CRANING:

1. Boats shall be kept in their assigned places in the boat park or in the harbor.
2. In concert with the harbor master a crane will be available on site to crane boats in and out the water.

19.HAUL-OUT RESTRICTIONS:

21.DATA PROTECTION:

1. By participating in this event, competitors automatically grant to the organizing authority and the event sponsors the right, in perpetuity, to make, use, and show, at their discretion, any photography, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.

22.RISK STATEMENT:

1. RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.
2. **The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.**

23.INSURANCE:

1. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of 1.500.000€ or the equivalent per incident.
